From Bergen County – Take Route 17 North or Route 208 North to I-287 South (towards Morristown). Leave I-287 at Exit 52B (Butler – Route 23). This will put you on Route 23 Northbound. Travel 4/10s of a mile to the Riverdale Square Mall (Gold's Gym, Pearle Vision, Ruppert's Rest.) on right. Vibe is in mall next to Gold's Gym.

From Morristown Area – Take I-287 North (towards Mahwah). Leave I-287 at Exit 52B (Butler – Route 23). This will put you on Route 23 Northbound. Travel 4/10s of a mile to the Riverdale Square Mall (Gold's Gym, Pearle Vision, Ruppert's Rest.) on right. Vibe is in mall next to Gold's Gym.

From Westchester- Rockland Counties – Take I-287 to Tappan Zee Bridge. Stay on I-287 south/I-87 north. When I-287 and I-87 split in Mahwah, NJ follow signs for I-287 south towards Morristown. Leave I-287 at Exit 52B (Butler – Route 23). This will put you on Route 23 Northbound. Travel 4/10s of a mile to the Riverdale Square Mall (Gold's Gym, Pearle Vision, Ruppert's Rest.) on right. Vibe is in mall next to Gold's Gym.

From Western, NJ – Take I-78 or I-80 East to get on I-287 north. Leave I-287 at Exit 52B (Butler – Route 23). This will put you on Route 23 Northbound. Travel 4/10s of a mile to the Riverdale Square Mall (Gold's Gym, Pearle Vision, Ruppert's Rest.) on right. Vibe is in mall next to Gold's Gym.

From New York City - Long Island - Leave New York via the George Washington bridge. Follow signs to get on I-80 west (express or local). Leave I-80 at exit 53 (Wayne, Bulter, Verona – Rt. 23) and follow signs to get on Route 23 North (Butler). Travel approximately 8 ½ miles to the Riverdale Square Mall (Gold's Gym, Pearle Vision, Ruppert's Rest.) on right. Vibe is in mall next to Gold's Gym.

West Milford, NJ, Orange County, NY – Warwick Area – Take State Route 94 South. Turn right onto County Route 21/Warwick Turnpike. Travel 5 ½ miles and turn right onto Clinton Road. Follow signs to get on Route 23 south. Travel approximately 8 miles. You will pass Lowe's on your left. You will see Staples on your left. Just past next traffic light bear right to take jughandle to cross Route 23 (you will be entering the Home Depot parking lot). At traffic light in Home Depot parking lot (the traffic light may be blinking) turn right towards Target. Drive toward main entrance to Target and turn right in front of store. Follow road keeping store on your immediate left to Stop sign. Turn right at stop sign (parking deck on your right). Turn left at "Riverdale Square" sign and go down winding steep hill to parking lot. Go straight keeping Ruppert's Restaurant on your left to main parking area. Vibe will be on your left next to Gold's Gym.

Northern, NJ – Passaic County – Take Route 23 South towards Butler. You will pass Lowe's on your left. You will see Staples on your left. Just past next traffic light bear right to take jughandle to cross Route 23 (you will be entering the Home Depot parking lot). At traffic light in Home Depot parking lot (the traffic light may be blinking) turn right towards Target. Drive toward main entrance to Target and turn right in front of store. Follow road keeping store on your immediate left to Stop sign. Turn right at stop sign (parking deck on your right). Turn left at "Riverdale Square" sign and go down winding steep hill to parking lot. Go straight keeping Ruppert's Restaurant on your left to main parking area. Vibe will be on your left next to Gold's Gym.
